Universal Design Daily: Lessons for ALL Learners (UDDAL)

**Course Description:**

This three-session webinar series, Universal Design Daily, will explore the categories of action, expression, representation, and engagement for a variety of students that a teacher may encounter in a classroom. The focus will be on options that support students sharing what they know and can do. Sessions will also look at ways for presenting material, boosting comprehension, and making concepts accessible and “sticky.” Finally, participants will examine ideas for creating “moments” in lessons and teaching to fascinations.

**Session 1: Provide a Path: UDL Action and Expression Ideas** – This first session participants will explore the learning differences of students and the underlying habits of mind related to “teaching them all.” It will look at options that support students in sharing what they know and can do as well as examine ideas for assessment and demonstration of learning.

**Session 2: Show, Tell, and Model: UDL Representation Ideas** – In this second session participants will look at perception and comprehension and strategies related to approaching content and illustrating ideas. Participants will examine ideas for presenting material, boosting comprehension, and making concepts accessible and “sticky.”

**Session 3: Pass the Rubber Chicken: UDL Engagement Ideas** – In the final session participants will explore engagement of learners. They will look at affect as it relates to learning and learn about strategies related to motivation, relevance, community, connection, and choice. There will also be a focus on ideas for connecting with individual students, creating “moments” in lessons, promoting wonder, and teaching to fascinations.

## University of Idaho Learning Objectives:

1. **Learn and integrate:** Through independent learning and collaborative study, attain, use and develop knowledge in the arts, humanities, sciences and social sciences, with disciplinary specialization and the ability to integrate information across disciplines.
2. **Think and create:** Use multiple thinking strategies to examine real-world issues, explore creative avenues of expression, solve problems and make consequential decisions.
3. **Communicate:** Acquire, articulate, create and convey intended meaning using verbal and non-verbal methods of communication that demonstrate respect and understanding in a complex society.

## Course Objectives:

1. Participants will describe the categories of Universal Design for Learning (UDL).
2. Participants will describe various options for students in sharing what they know and can do.
3. Participants will identify ways to present materials and boost comprehension for a variety of students.
4. Participants will describe how to change a lesson to create more access for students.

## Required Materials:

There are no outside readings or materials required for this course. Handouts for each webinar session are located in the course site at the Idaho Training Clearinghouse LMS.

Identify the changes you would make and write a short 1-2 paragraph description of each proposed change. Use the principles of language/model of UDL to support the proposed changes.

## Grading:

This is a Pass/Fail course. No incompletes will be given. Late work will not be accepted.

1. Participants must earn an 80% score on each quiz to pass the course. Quizzes can be retaken until passed.
2. Credit participants must earn an 80% (80/100) on the final written assignment to pass the course.
