**Course Description:****Session 1: Building Student Portfolios**

This session will address essential self-determination practices and use the process of building students portfolios to increase self-awareness and helping students advocate for themselves.

**Session 2: Goal Tracking Tools**

This session will discuss various goal tracking tools and strategies for actively involving students in setting goals, self-evaluating their performances, and monitoring their progress.

**Session 3: Leadership within the School Community**

This session will address strategies for helping students experience increased positions of leadership in the school community. Participants will learn how all of these strategies can apply to students at various ages and across disabilities.

**University of Idaho Learning Objectives:**

1. **Learn and integrate:** Through independent learning and collaborative study, attain, use and develop knowledge in the arts, humanities, sciences and social sciences, with disciplinary specialization and the ability to integrate information across disciplines.
2. **Think and create:** Use multiple thinking strategies to examine real-world issues, explore creative avenues of expression, solve problems and make consequential decisions.
3. **Communicate:** Acquire, articulate, create and convey intended meaning using verbal and non-verbal methods of communication that demonstrate respect and understanding in a complex society.

## Course Objectives:

1. Participants will describe the components of a student portfolio
2. Participants will describe the process of developing a student portfolio
3. Participants will describe two tools for tracking goals
4. Participants will describe strategies for involving students in setting goals
5. Participants will discuss strategies for involving students in leadership roles
6. Participants will describe examples of how students at various ages and disabilities can be involved in leadership activities
