Literacy Ideas for Students who Have Severe and Profound Disabilities (LSPD)

**Course Description:**

**Session 1:** "What is Literacy for Students who Have Severe and Profound Disabilities?" – This session will compare traditional literacy to literacy for this population of students. Participants will identify what skills are involved in literacy for these students and consider how to provide opportunities for their students to develop literacy.

**Session 2:** "What Literacy Skills do Your Student(s) Already Have?" – In this session participants will complete a literacy checklist and consider why they think a focus student has those skills. Participants will consider what literacy activities to provide a student(s) to help improve or acquire more literacy skills.

**Session 3:** "How do I Provide Enough Literacy Opportunities Throughout the School Day?" – This final session will target the general schedule the focus student follows on a typical day. Participants will discuss how literacy skills can be integrated into daily routines.

3. **Communicate:** Acquire, articulate, create and convey intended meaning using verbal and non-verbal methods of communication that demonstrate respect and understanding in a complex society.

2. Participants will describe the components of a literacy checklist
3. Participants will describe various literacy activities
4. Participants will identify how to align daily routines to a literacy skill

## Grading:

2. Credit participants must earn an 80% (80/100) on the final written assignment to pass the course.
